

## Caution:

- This light panel is ideally used on smooth surfaces (e.g. glass, wood, etc); not suitable for uneven, bumpy or wet surfaces (e.g. brick, stucco, etc)
- Clean and ensure the surface is totally dry before sticking the light panel on.
- When installing the light panel, press its central point against the wall for more than 30s in order to maximize the adhesion.

## Safety Instructions

Read and follow all the safety instructions:

- The light panel is not waterproof. Avoid exposing it to splashing or dripping water.
- The operating temperature should be within -10° to 40°C (14° to 104°F).
- The light panel's internal light source cannot be replaced. If it breaks, you must replace it.
- Do not allow children to install the light panel alone.
- Avoid placing the light panel near heat sources.
- Do not install the light panel with a dimming driver.
- Avoid placing the light panel near potentially dangerous sources (e.g., candles, liquid-filled objects).

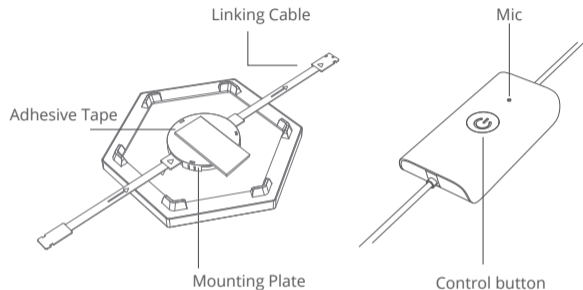

## Pairing Your Device with the Govee Home App

What you need:

A Wi-Fi router supporting the 2.4GHz and 802.11 b/g/n bands. 5GHz is not supported.

Pairing instructions

- 1 Download the Govee Home app from the App Store (iOS devices) or Google Play (Android devices).
- 2 Open the app, tap the "+" icon in the top right corner and search for "H6061".
- 3 Tap the device icon and follow the onscreen instructions to complete pairing.

## Troubleshooting

❶ Cannot connect to the Govee Home app.

- Check if the light panel is powered on.
- Check if Bluetooth on the smartphone is enabled, or try connecting with another smartphone.
- When connecting for the first time, ensure the smartphone is near the light panel.
- If the connection error still exists, please delete the connected light panel from “My Device” on the app. Reconnect to the Govee Home app by following the instructions provided previously.

❷ Wi-Fi disconnected or failed to connect.

- Check if the light panel is powered on.
- Do not skip the Wi-Fi connection steps during the light panel pairing process.
- Ensure your Wi-Fi router is 2.4GHz (5GHz is not supported).
- Ensure you entered the correct Wi-Fi password during the Wi-Fi set up process.
- Try connecting the light panel with a smartphone hotspot to check if your home network is working properly.
- Shorten the distance between the light panel and the Wi-Fi router to less than 1m, then reconnect.

❸ Cannot connect to Alexa or Google Assistant.

- Ensure the Wi-Fi connection is stable and working properly.
- Go to “User Guide” on the app Settings page to pair the light panel again.

❹ Can multiple users control one light panel.

- Each light panel can only be controlled by one account.
- If multiple users want to manage the same light panel, ensure they all use the same account.
